Jonathan, son of Cornelius and Eunice Cook, b. Oct. 13, 1727 (WVR 35) Jonathan mar. Mary Biglow, Apr. 26, 1758 (WVR 140) No children in WVR, Northborough VR Mary, dau. of Jonathan and Mary, d. Feb. 5, 1844 Molly, dau. of Jonathan and Marsy, d. Feb. 8m, 1844, a. 87 (WVR 234)

1758 March 15 (Wednesday). Jonathan Cook here and wants my Other place this Year.

1758 April 26 (Wednesday). In the Evening marryed *Thomas Hardy* and *Hephzibah Rice* and after them went through the service again for <u>Jonathan Cook</u> and Mary Biglow. N.B. This last gave a Dollar.

1758 November 6 (Monday). Mr. Jonathan Cook here, being returned from the Lake -- says that Capt. Maynards Company were so Sickly and indisposed, that there were none but what had been at one time or another taken off from Duty except my Son William and two more.

1758 November 16 (Thursday). N.B. Widow Twitchell tells me (Mr. *Ebenezer Nurse* and Mrs. *Rebecca Warrin* present) that Judge Ward may go into her House if he will fit it up at his own Cost, and engage to leave it next spring when Mr. Jonathan Cook will want to have it. Which I Acquaint the Judge with.

1760 July 11 (Friday). Mr. Jonathan *Cook* here and wants to have his Child baptized. Refer him to Mr. Martyn -- the way not being wholly clear without a Certificat from him.

1765 July 30 (Tuesday). At Eve **Jonathan Cook** came to me with a Sorrowful Message from Capt. Maynard that his youngest Child was drowned and dead and prayed me to go over.

1769 June 18 (Sunday). Mr. Jonathan Cook this morning fell into a Coal Pit; and though he got out again, yet not without being much burnt.

1771 April 22 (Monday). Received a Letter by Hand of Mr. Abraham *Bonds* Wife, from *Mr*. *Jonathan Cook* and wrote some Reply, but did not send it now.

1771 May 21 (Tuesday). Mrs. *Hitty Brigham* with me, and is uneasy about the Conduct of Mr. *Jonathan Cook* whom she has hired to work for her.

1771 May 22 (Wednesday). Mr. Jonathan Cook here, but I softened him with Gentle Words.

1772 January 30 (Thursday). Though it was rough weather I went to see old Mrs. Beeman at Mr. Jonathan Bruce's. Dined there. Prayed with them. N.B. Mr. Bruce Speaks of Mr. Jonathan Cook and that he had been dismissed from their Church. I answered that I knew not that ever I received or ever saw, any.

1776 July 19 (Friday). Mr. Jonathan Cook here. He has listed to go to New York. Discovers his Infidelity, respecting the Scriptures, and of the Son of God.
